

International Chamber of Commerce of Seattle

Chapter I: General Provisions

Article 1 The name of this Chamber of Commerce is the Seattle International Chamber of Commerce (hereinafter referred to as "the Chamber"):

International Chamber of Commerce of Seattle, English abbreviation is ICCS.

Article 2 The Chamber of Commerce is a non-religious, non-profit organization legally registered in the State of Washington, USA.

Article 3 The members of the Chamber of Commerce are engaged in international trade, project investment, legal services, tax consultation, Commercial banks, medical institutions and other services.

Article 4 The purpose of the Chamber of Commerce is to promote the investment and development of enterprises in the United States from all over the world; To promote the investment and development of American enterprises in all countries of the world. For the international trade, project investment, real estate development, travel insurance, Culture and art, health care, exhibition promotion, study and study abroad and other fields provide a full range of services. To become a link and bridge between enterprises in all countries of the world.

Article 5 The Chamber of Commerce strictly abides by the Constitution and state laws of the United States. All types of mediation, training and counselling services are carried out within the strict legal framework.

Chapter 2: Business Scope Article 7 The scope of services of the Chamber of Commerce:

- (1) to set up information platform for members and enterprises and related institutions around the world, to provide various kinds of business information;
- (2) to provide legal, tax and financial advisory services to members;
- (3) introducing the investment environment and best policies of the United States and other countries around the world; To assist members in communication and coordination with government authorities;
- (4) to provide communication, communication, negotiation, recommendation, Promotion opportunities and platforms to help members gain trading development opportunities and improve competitiveness;
- (5) to carry out other public welfare and charitable activities beneficial to the society according to the requirements of the members.

Chapter 3: Membership System

Article 8: Members of the Chamber of Commerce are individual enterprise members and group enterprise members.

Article 9 Membership of the Chamber of Commerce shall meet the following conditions:

- (1) to uphold the Articles of Association of the Association;
- (2) to safeguard the legitimate rights, interests and reputation of the

Chamber;

- (3) have a certain influence in the industry and related fields;
- (4) to operate in accordance with the law within the last three years, to abide honestly by the law, to protect the environment, and to perform social responsibilities; No bad records, no violations.

Article 10 Entry Procedure

- (I) Submit an application;
- (2) to submit copies of business licenses and registration certificates issued by government departments;
- (3) The Chamber of Commerce shall examine and approve the membership of the Association and go through the formalities of membership of the Association after the approval by the President;
- (4) the certificate of membership issued by the Association;
- (V) Contributions:

Individual corporate membership: US\$2,000/year;

Group corporate membership: US\$10,000/year.

Article 11 Rights enjoyed by Members

- (1) to give priority to participating in the various activities organized by the Council;
- (2) the priority and privileges of obtaining the services of the Association;
- (3) to have the right to advise and supervise the Council;
- (4) the freedom to enter and withdraw voluntarily;

Article 12 Members shall perform the following duties:

- (1) to abide by the Articles of Association of the Chamber;
- (2) to safeguard the legitimate rights, interests and reputation of the Chamber;
- (3) to implement the resolutions and decisions made by the Chamber of Commerce;
- (4) to pay the contribution as required.

Article 13 The member shall submit a written application for withdrawal and return the certificate of membership and relevant information to prove the membership status Article 14 The member shall be removed if there is a serious violation of the Articles of Association of the Chamber
